




COVID-19 Testing and Vaccination Program

ore than 200,000 vaccinations have been administered by UHC health centers and mobile teams. To those FQHCs across the country, UHC was one of the first that HRSA provided direct vaccine shipments to expedite vaccinations to underserved communities. Our UHC health centers averaged 1,200 vaccinations per week while the mobile teams vaccinated employees at agricultural businesses and sought to create vaccination opportunities for the general public. UHC continued to increase its capacity to serve. Our UHC Marketing Department worked with Counties and Cities on campaign strategies to combat vaccination hesitancy once vaccines became widely available and restrictions were lifted. COVID-19 testing remains an essential tool in combating the spread, and we continue to test with more than 250,000 tests conducted.


UHC performed COVID-19 tests by using major community events throughout Fresno County, including testing for student-athletes at several schools like Central Unified District on 7 occasions, Fresno City College on 12 occasions, and Sanger Unified District on 18 occasions. Additionally, high school staff at Fresno USD were tested at Bullard High School and McLane High School, Central USD staff at Koligian Stadium, and Learn-4-Life/Crescent View staff were tested both in Lemoore and at the Manchester Center. Thirteen community COVID-19 vaccination events were performed using first and second doses at Koligian Stadium in Fresno and at the Sanger and Parlier High Schools, including children ages 12-18. Single-dose vaccines were also administered to adults at community events on Saturdays at the Mendota health center and the Milburn health center.

The total number of vaccinations provided at all UHC health centers including, drive-up vaccinations had reached 108,350. UHC staff also provided convenient opportunities for communities, businesses, and schools to get the recommended COVID-19 vaccinations throughout the year. Many events had focused on school-based athletic programs and instructors

in preparation for returning to the classroom in the fall. Those schools include Fresno City College, Central Unified, Computech Middle School, and Fresno High School. Businesses such as Clawson Honda of Fresno and community events like the Fowler Farmers Market had also been scheduled.

Health Resource Services Administration (HRSA) Review



HRSA Review - UHC Leadership gathered together for the opening morning.

HC completed a comprehensive program assessment by the Health Resource Services Administration (HRSA) in three days, from June 23rd through the 25th. The HRSA Site Review is routinely conducted every three years and is designed to ensure that each Federally Qualified Health Center (FQHC), as recipients of the federal 330 grant, complies with the specific requirements of the grant approved by Congress. George Chatyrka, UHC's HRSA Compliance Director, has worked tirelessly over many months to ensure all requested

documentation was current, accurate, and compliant with HRSA expectations. The review encompassed all areas of the organization's performance, including; the program elements for the UHC Board of Directors, Executive Leadership, the departments of Finance, IT, Operations, HR, Business, and all pertinent patient record keeping, billing, and communications. The review went exceptionally well, and UHC received several accolades on the proficiency of the review.

Annual Strategic Planning Conference



HC held an Annual Strategic Planning Conference in Monterey, CA, November 12th -14th. UHC Board Members, Executive, and Key Staff reviewed the past 18 months covering accomplishments, challenges, and potential changes to the strategic goals discussed when the group last met in 2019. Operations during the pandemic have been very challenging. Yet, there have been numerous accomplishments, including the successful HRSA site review in June and our continued growth with six new health centers in 2020 and another three that opened in 2021. Employment also grew to over 1,000 in 2021 with more than 500 new employees hired over the last two years.

Fresno-Ashlan Health Center

The Fresno - Ashlan health center is located at 2848 W. Ashlan Avenue in Fresno, CA 93705. The renovation of a former drug store of approximately 13,855 square feet. It will offer comprehensive primary care services and include 14 medical exam rooms, 10 dental chairs, 3 optometry rooms, 2 behavioral health rooms, 2 chiropractic treatment rooms and x-ray and laboratory services. It will also feature a separate Urgent Care Suite with 4 treatment rooms. The completion date is anticipated for Spring 2023.

Fresno-Church Avenue Health Center

The Fresno - Church Avenue health center is located at 5090 E. Church Avenue in Fresno, CA 93725, at Juan Felipe Herrera Elementary School. The project is 1,700 square feet and is planned to include 4 medical exam rooms, 1 behavioral health room, and laboratory services. The completion date is anticipated for Fall 2022.

Fresno-First Street Health Center

The Fresno - First Street health center is located at 4615 N. First Street in Fresno, CA 93726. The renovation project is approximately 13,488 square feet, with comprehensive primary care services planned to include 12 medical exam rooms, 10 dental chairs, 4 optometry rooms, 1 behavioral health room, 2 chiropractic treatment rooms, and x-ray and laboratory services. The completion date is anticipated for Spring 2023.

Fresno-Minnewawa Health Center

The Fresno - Minnewawa health center is located at 645 S. Minnewawa Avenue in Fresno, CA 93727. It will be an all-new building of approximately 19,990 square feet with comprehensive primary care services. It will include 22 medical exam rooms, 14 dental chairs, 6 optometry exam rooms, 3 behavioral health rooms, 2 chiropractic treatment rooms with ancillary services to include lab and x-ray. The builder for this location is Legacy Construction Company, and the completion date is anticipated for Spring 2022.

Hanford Health Center

The Hanford health center is located at 1545 Mall Drive in Hanford, CA 93230. It will be the third location for UHC in Kings County. The renovation project is approximately 8,936 square feet in size with comprehensive primary care services that will include 9 medical exam rooms, 7 dental chairs, 2 behavioral health rooms, 2 chiropractic treatment rooms, and x-ray and laboratory services. The builder for this location is Legacy Construction Company, and the completion date is anticipated for Summer 2022.

Fowler Health Center

The Fowler - Sixth Street health center is located at 130 6th Street in Fowler, CA 93625. The new building will be approximately 4,950 square feet and the second UHC health center in Fowler. The new location on 6th Street will be adjacent to the Main Street location. It will complement the existing health center with comprehensive primary care services to include 9 medical exam rooms, 2 chiropractic treatment rooms, and x-ray and laboratory services. The completion date is anticipated for Fall 2023.

Kingsburg Health Center

The Kingsburg health center is located at 1251 Draper Street in Kingsburg, CA 93631. The renovation of an existing building of approximately 5,500 square feet will be the first UHC health center in Kingsburg. It is planned to offer comprehensive primary care services equipped with 7 medical exam rooms, 1 behavioral health office, 2 chiropractic exam rooms, and laboratory services. The completion date is anticipated for Fall 2022.

Visalia Health Center

The Visalia health center is located at 4038 S. Mooney Blvd. in Visalia, CA 93277. It will be the third location for UHC in Tulare County and the first in the City of Visalia. The renovation project is approximately 17,044 square feet with comprehensive primary care services planned to include 14 medical exam rooms, 12 dental chairs, 6 optometry rooms, 1 behavioral health office, 2 chiropractic treatment rooms, and x-ray and laboratory services. This location will also feature a separate Urgent Care Suite with 3 treatment rooms. The completion date is anticipated for Winter 2022.

Fight Against Breast Cancer in Partnership with Alinea Mammogram Mobile

In September, the UHC Referral Department partnered with Alinea Mammogram Mobile to perform mammogram screenings for UHC patients at UHC health centers in Fresno County. The purpose was to increase screenings and reach our annual target of 50% of eligible patients by improving access by bringing the mobile unit to rural locations. Alinea's Mobile service typically screens around 20

women daily, but the average daily number rose to 31 screenings a day by working closely with UHC. The program was limited to UHC patients, but word quickly spread among families. In 2021, UHC brought 5 events per month to our health centers in Sanger, Parlier, Kerman, Mendota, and Huron. 1,202 women received mammogram screenings through this critical program.



UHC Attends Several National Night Out Events

Our local UHC health centers participated in nationally celebrated community events organized by local Police Departments. National Night Out is an annual community-building campaign that promotes police-community partnerships and neighborhood camaraderie to make our neighborhoods safer, more caring places

to live. The events historically begin on the first Tuesday in August. Several community leaders also attended the events in Selma, Orange Cove, Parlier, Huron, and Kerman. UHC health centers and marketing staff provided essential health and educational information while also performing screening activities.

A grant from the Corcoran District Hospital has provided the necessary funding to begin serving Corcoran residents and its surrounding communities with easy access to urgent health care services on weekends and after-hour care on weekdays at the UHC Corcoran Urgent Care Center. Through this Grant to UHC, Corcoran residents can now obtain ready access to afterhour care for the first time since the local hospital closed its emergency room in 2013.

Through collaboration between the Outreach Department and UHC administration's medical staff and medical staff from our various health centers, UHC can successfully plan, set up, and create

memorable experiences for our communities. These community events make it possible for United Health Centers to reach people face-to-face and provide them with information about our services, free blood pressure tests, health information, and prizes. Through outreach events, the department has made over 3,200 personal interactions with potential patients. More than 300 graphic designs were approved for printing and distribution. And there was a 218% increase in the number of people reached via social media with a 130% increase in website visits.
